

The author (or perhaps publisher) have limited the kindle edition licenses to only 2 devices. I like to be able to view e-textbooks on my phone, tablet and laptop so that I can more easily complete readings and assignments on the go, so having to pick 2 of these 3 was aggravating. As for the more important issues, content and presentation, this textbook leaves much to be desired. It is riddled with typos, which is frustrating, but even more worrisome is the presence of serious bias. The textbook uses point/counter point articles to discuss issues like the benefits/detriments of globalization. Unfortunately, many of these are designed with one point being populated exclusively with 'straw man' arguments. This thread of misrepresenting complex issues arises outside of flawed pseudo-debates as well. Much better alternatives are available.

This book is a very interesting read if you have the time. I'm doing an international business course at university and if you take in to consideration a lot of what they say and apply it it can be a very useful tool. Some of their points are debatable but it's the same with every text book. The point counterpoint sections do a brilliant job of giving both sides of a lot of interesting topics.

This was a required textbook for an international business management class which I never opened after the class started. I'm still kind of upset with the professor for making us buy it. The book is really extremely dry so I'd never read it just for leisure.
