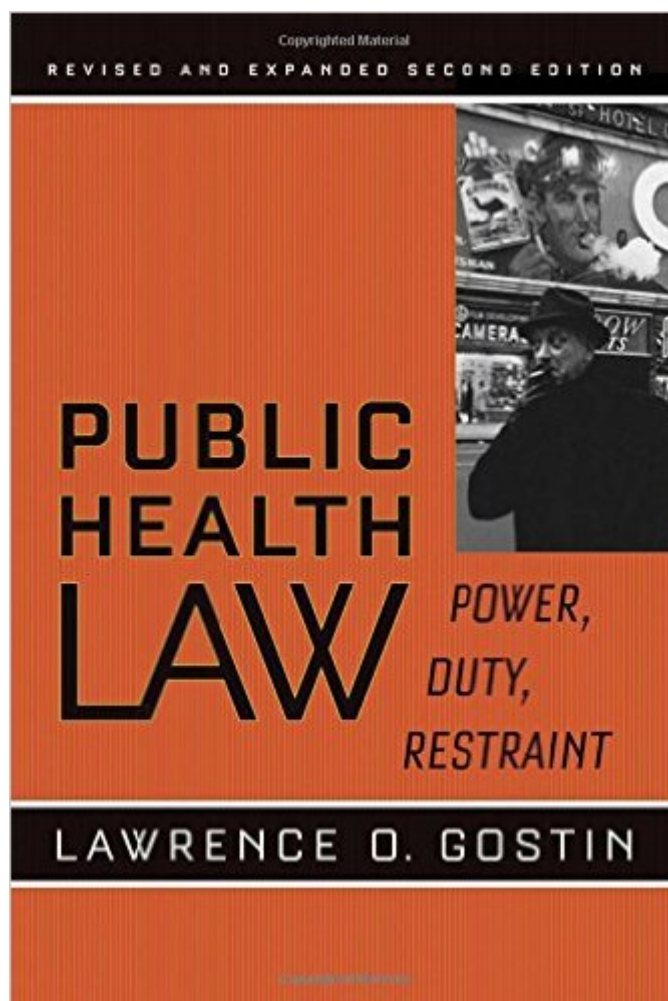

However, it's not the most current and given the drastic technological advances and public health law issues raised within the past few years, it's more than overdue for a refresh. My only criticism would be that it's WAAAAAY WAAAAAY WAAAAAY too repetitive of the reader.

Very interesting book so far. It's very descriptive, informative and simple to understand. I definitely like the author's simple approach to the subject matter. This book was actually a second choice of my professor because the price is much more affordable than comparable textbooks. I think this author does a great job with presenting the information.

The best part of this book is its index. After reading the Showalter Law in Health Administration text, this Gostin Public Health Law text makes me want to stick a fork in my eye. I struggled to make it through every chapter. It's verbose, unbelievably redundant, and over-complicates and beleaguers simple material. I would not recommend it. If you are in a course that uses it as a primary text book, drop the course.

Public Health Law has not attracted academic interest in Europe among Medical Law professionals. De facto, it has remained an untouched area. Therefore I was amazed to find this comprehensive title. Although it bases much on US law and case law, it still captures the essential points of PHLaw applicable everywhere. It is an fascinating story in terms of history, cases, human rights etc. It is also interesting for those interested in regulation theory.
